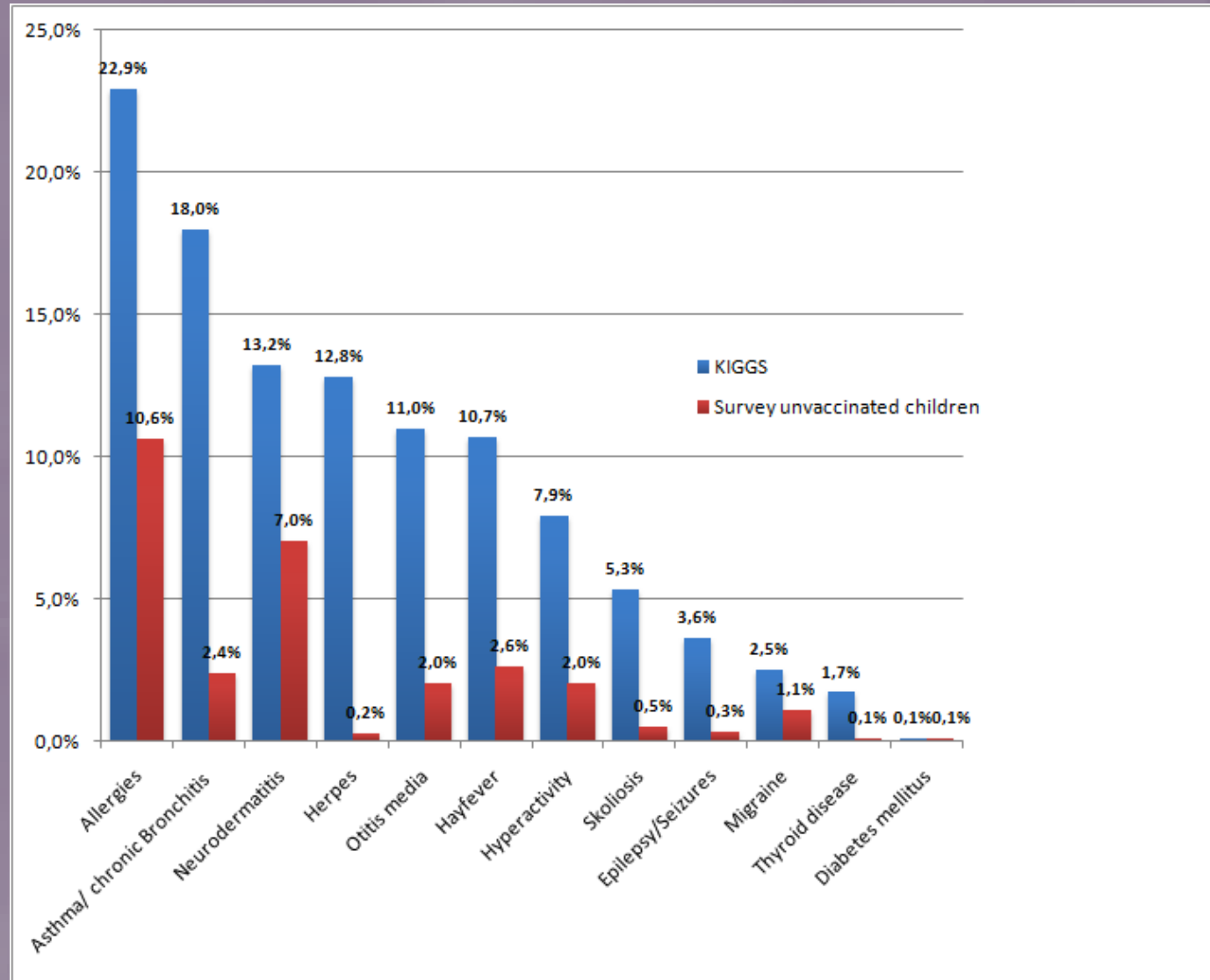


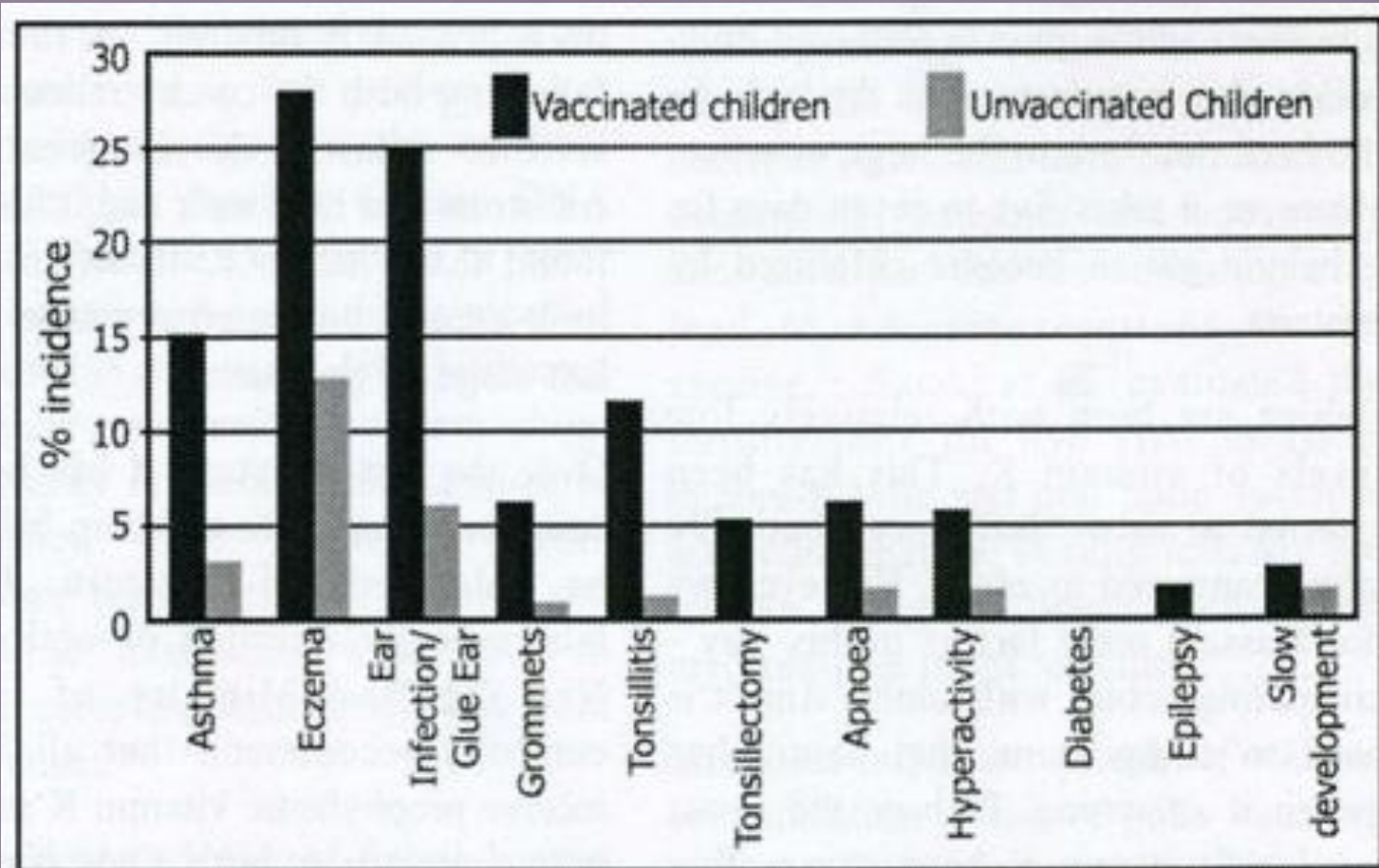

# Mumps Outbreak in Orthodox Jewish Communities in the United States

New England Journal of Medicine Nov 1<sup>st</sup> 2012

## Study Results synopsis:

From June 28, 2009, through June 27, 2010, a total of **3502 outbreak-related cases of mumps were reported in New York City**, two upstate New York counties, and one New Jersey county. Of the 1648 cases for which clinical specimens were available, **50% were laboratory-confirmed**. Orthodox Jewish persons accounted for 97% of case patients.

Adolescents 13 to 17 years of age (27% of all patients) and males (78% of patients in that age group) were disproportionately affected. Among case patients 13 to 17 years of age with documented vaccination status, **89% had previously received the required two doses of a mumps-containing vaccine**, and 8% had received only one dose.



# 3 Girls Dead, Others Hospitalized After Gardasil HPV Vaccine

Following controversy over U.S. state legislatures requiring young girls to take Gardasil, Merck's vaccine for human papillomavirus (HPV), a number of severe side effects have been observed along with the *recent* deaths of 3 young girls.

As of January **2010**, Gardasil has been linked to 49 deaths and countless side-effects, while cancer, associated with HPV, is only responsible for 1% of *all cancer deaths*. Why then, is it being recommended to millions worldwide?

Out of 15 million people, 49 deaths may not seem like a lot. Unfortunately, however, there are many more cases of extreme side effects from the vaccination. **In fact, the amount of adverse reactions was so high that Judicial Watch, a group that claims to expose government corruption, was forced to step in to investigate.**

**Between May 2009 and September 2010 alone**, Gardasil was linked to 3,589 harmful reactions and 16 deaths. Of the 3,589 adverse reactions, many were debilitating. Permanent disability was the result of 213 cases; 25 resulted in the diagnosis of Guillain-Barre Syndrome; and there were 789 other "serious" reports according to FDA documents.

“It is simply no longer possible to believe much of the clinical research that is published, or to rely on the judgment of trusted physicians or authoritative medical guidelines. I take no pleasure in this conclusion, which I reached slowly and reluctantly **over my two decades as an editor of *The New England Journal of Medicine***” – Marcia Angell, MD.
